ARTICLE I

NAME

The name of the Corporation shall be Perdido Bay Youth Sports Association, Inc.

ARTICLE II

ADDRESS

The place in this state where the principal office of the Corporation is to be located in the City of Pensacola, Escambia County.

The official address is 13705 Sorrento Road, 32507. The mailing address is P. O. Box 34469, Pensacola, FL 32507.

ARTICLE III

PURPOSE

The purpose in which this organization is organized are: to provide a supervised program under the policies and rules set forth by the Officers and Board of Directors of this Corporation, to teach the children of this community the ideals of good sportsmanship, loyalty, friendship and respect for authority. Officers and members shall bear in mind that the achieving of exceptional athletic skills or the winning of games is secondary and the molding of future citizens is the prime importance.

ARTICLE IV

LIMITATION OF CORPORATION POWERS

The conduct of the corporation will be limited in the following manner: To the Bylaws of the Corporation. The powers of the corporation are to be limited as to the Bylaws of the Corporation. The powers of the officers and directors are to be limited as to the Bylaws of the Corporation.

No part of the earnings of the corporation shall insure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable to compensation for services rendered and to make payments and distributions furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of the opposition to any candidate for public office. Notwithstanding any other provision of these article, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.

ARTICLE V

REGISTERED AGENT AND STREET ADDRESS

The street address of the initial registered office of this corporation is 1915 Merlin Road, Pensacola, Florida, 32506, and the name of the initial registered agent of this corporation at that address is James E. Mooney.

ARTICLE VI

MEMBERS

The corporation shall have members. Members of the Corporation will be required to meet the following qualification: that they be sympathetic and be in accord with the nature and object of the corporation and desire to further the same by active participation as members of the corporation.

Any person actively interested in furthering the objective of the park may become a regular member upon the payment of the prescribed fees. All parents and/or guardians of the children participating in the activities provided by the

corporation shall be required to be a member of the corporation. Persons shall be admitted into membership of the corporation at the time they register their child to participate in the activities of the corporation at the time they registered their child to participate in said activities of the corporation and by the payment prescribed fees. Members shall maintain a role of membership to qualify voting members. Any new members will have equal voting rights as a member after a period of fifteen (15) days from the date they pay their fees.

ARTICLE VII

DISSOLUTION OF CORPORATION

If upon the necessity for Perdido Bay Youth Sports Association, Inc. should dissolve baring no replacement governing body, the assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or shall be distributed to federal government, or to the state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes

ARTICLE VIII

OFFICERS

The elected officers of the Perdido Bay Youth Sports
Association shall be: a President, a Vice President, a
