ARTICLES OF AMENDMENT OF BAPTIST HEALTH CARE CORPORATION

STATE OF FLORIDA

We, the Chairman and the Assistant Secretary of Baptist Health Care Corporation, a notfor-profit corporation organized under the laws of the State of Florida (the "Corporation"), do hereby make and attest these Articles of Amendment, and certify as follows:

- 1. The name of the Corporation is Baptist Health Care Corporation.
- 2. The following amendment has been adopted in accordance with the requirement set forth in Chapter 617, Florida Statutes:
 - (a) Article II of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following Article II:

ARTICLE II. PURPOSES

Promote and support, by donation, loan or otherwise, the interests and purposes of Baptist Hospital, Inc., Baptist Manor, Inc., Azalea Trace, Inc., Baptist Health Care Foundation, Inc., Lakeview Center, Inc., Escambia County Alabama Community Hospitals, Inc., and Jay Hospital, Inc., which Corporations provide health care, education or research, or otherwise conduct activities in support of health care, education or research, and which fall within the categories of Section 501(c)(3) and Section 509(a)(1) or Section 509(a)(2) of the Internal Revenue Code of 1986.

(b) Article VIII of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following Article VIII:

ARTICLE VIII. CONTEMPORANEOUS SERVICE

At least one member of the Corporation's Board of Directors shall at all times serve contemporaneously as a Director of Baptist Hospital. Inc.

(c) Article XI of the Articles of Incorporation of the Corporation is deleted in its entirety, and replaced with the following Article XI:

ARTICLE XI. DISSOLUTION

In the event of the dissolution of the Corporation, the Board of Directors, after paying or making provision for the payment of all of the liabilities of the Corporation, shall dispose of all of the assets of the Corporation to Baptist Hospital, Inc., if then in existence and if qualified under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or otherwise in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational or scientific purposes to benefit the inhabitants of the general area of Pensacola, Florida, as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law, as the Board of Directors shall determine. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the Corporation is then located, exclusively for

such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

3. The foregoing amendments were adopted by a vote of the Corporation's Board of
Directors at a duly called and noticed meeting on the 5th day of February, 2001, which
vote was sufficient for the amendment's approval. Members are not entitled
to vote on a proposed Amendment.
