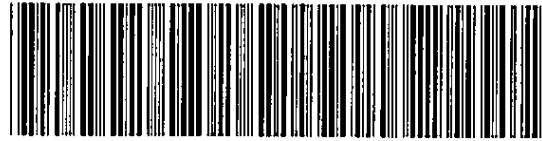

ARTICLE I
NAME

The name of this corporation is ST. JAMES EPISCOPAL CHURCH
OF ORMOND BEACH, INC., a non-profit Florida Corporation.

ARTICLE II
DURATION

This corporation shall have perpetual existence commencing
on the date of filing.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of the support of
the public worship of Almighty God, according to the faith and
discipline of the Protestant Episcopal Church of the United States of
America and the Episcopal Church in the Diocese of Central Florida.
It acknowledges itself to be a member of and to belong to the said
Church in the United State of America and to the said Church in the
Diocese of Central Florida. As such it accedes to, recognizes and
adopts the constitution, canons, doctrine, discipline and worship of
The Protestant Episcopal Church in the United States of America, and the
constitution and canons of The Protestant Episcopal Church in the Diocese
of Central Florida

ARTICLE IV
MEMBERSHIP

The members of the corporation who shall be qualified to vote at
any election for members of the Vestry (Board of Directors) and upon all
questions which may properly come before any meeting of the congregation

shall be all such members of the congregation as may be qualified voters at parish elections for Vestrymen (Directors) under the canons of The Protestant Episcopal Church regulating the subject in the Diocese of Central Florida.

ARTICLE VI
OFFICERS

The officers by whom all the affairs of the corporation are to be managed are:

(1) Rector who shall be elected by the Vestry (Board of Directors) subject to the approval of the Bishop of the Diocese of Central Florida and who shall continue in the office until a vacancy shall be created by resignation or death or removal according to the canons aforesaid. He shall, when present, preside, with the right to vote at all Parish and Vestry Meetings, except when the Bishop by the said canons shall have the right to preside at a Vestry Meeting. The Rector's other duties and privileges are those prescribed by the said canons.

(2) A Vestry (Board of Directors) of no fewer than five adult male communicants of this corporation who are qualified voters thereof. They shall be chosen by ballot at an annual meeting of the members of the corporation to be held on or about January fifteenth. They shall have power to fill all vacancies which may occur in their

body during the year and in such elections a plurality of votes shall decide the choice. Of the persons chosen as Vestrymen (Directors), two shall annually be appointed by Rector as Senior and Junior Wardens. The Vestry (Board of Directors) shall elect annually a Secretary and a Treasurer. The offices of Secretary and Treasurer may be held by the same person.

ARTICLE VII POWERS AND DUTIES

No real property held by the corporation shall be encumbered or sold without the consent of the Trustees of the Diocese of Central Florida. All conveyances shall be signed in the corporate name by the Rector if there be one, and by the Senior and Junior Wardens under the common seal of the corporation.

The other privileges and duties of the Vestry, the Wardens, the Secretary and the Treasurer, shall be such as provided in the canons of the said Church in the United States of America and in the Diocese of Central Florida.

The By-Laws of the corporation (which must not be inconsistent with the canons aforesaid nor with this Charter) are to be made, altered or rescinded by the Vestry (Board of Directors).

ARTICLE XI AMENDMENTS

These Articles of Incorporation may be amended at a meeting of the Vestry (Board of Directors) by a majority vote of the members present and voting.

ARTICLE XII DISSOLUTION

In case of the dissolution of the corporation, all of its property on the winding up of its affairs shall vest in the corporation known as the Trustees of the Diocese of Central Florida, in trust to hold and convey the same to and for some existing or future congregation in the said City of Ormond Beach, Florida of members of the Protestant Episcopal Church in the Diocese of Central Florida, and to and for no other purpose.

a non-profit corporation approved by the Circuit Judge in Volusia
County, Florida, on July 20, 1954.

We, likewise present the attached "Articles of Incorporation"
for the purposes of reincorporation under the terms and provisions
of Florida Statutes Chapter 617, as amended by the Florida Legislature
in 1959, under Chapter 59-427, and hereby accept the same.

We, the undersigned, do hereby associate ourselves together for the purpose of forming a corporation not for profit under the general laws of the State of Florida, for the incorporation of religious societies, and to that end do adopt and propose the following:

1. The name of the corporation shall be ST. JAMES' EPISCOPAL CHURCH and it is to be located at Ormond Beach, Volusia County, Florida.

2. The general nature of the object of the corporation is the support of the public worship of Almighty God, according to the faith and discipline of The Protestant Episcopal Church in the United States of America, and of The Protestant Episcopal Church in the Diocese of South Florida. It acknowledges itself to be a member of and to belong to the said Church in the United States of America and to the said Church in the Diocese of South Florida. As such it accedes to, recognizes, and adopts the constitution, canons, doctrine, discipline and worship of The Protestant Episcopal Church in the United States of America, and the constitution and canons of The Protestant Episcopal Church in the Diocese of South Florida.

3. The members of the corporation who shall be qualified to vote at any election for members of the Vestry and upon all questions which may properly come before any meeting of the congregation shall be all such members of the congregation as may be qualified voters at parish elections for Vestrymen under the canons of The Protestant Episcopal Church regulating the subject in the Diocese of South Florida.

No person who shall disclaim or refuse conformity with and obedience to the constitution, canons, doctrine, discipline or worship of The Protestant Episcopal Church in the United States of America or of The Protestant Episcopal Church in the Diocese of South Florida shall be a member of this Church or corporation nor shall any such person be eligible for membership therein, nor shall any such person vote for vestrymen or be elected a member of the Vestry, or exercise any function in, concerning or connected with this Church or corporation.

4. The term for which the corporation is to exist shall be perpetual.

6. The officers by whom all the affairs of the corporation are to be managed are:-

(1) A Rector who shall be elected by the Vestry subject to the approval of the Bishop of the Diocese of South Florida and who shall continue in office until a vacancy shall be created by resignation or death or removal according to the canons aforesaid. He shall, when present, preside, with the right to vote at all Parish and Vestry meetings, except when the Bishop by the said canons shall have the right to preside at a Vestry meeting. The Rector's other duties and privileges are those prescribed by the said canons.

(2) A Vestry of not fewer than five adult male communicants of this corporation who are qualified voters thereof. They shall be chosen by ballot at an annual meeting of the members of the corporation to be held about January fifteenth. They shall have power to fill all vacancies which may occur in their body during the year and in such elections a plurality of votes shall decide the choice. Of the persons chosen as Vestrymen, one shall annually be elected by

the Vestry as Junior Warden. The Vestry shall also elect annually a Secretary and a Treasurer. The offices of Secretary and Treasurer may be held by the same person.

Meetings of the Vestry shall be held annually on or before January fifteenth to receive reports of officers and committees, pass on the same and turn over the affairs of the corporation to the newly elected Vestry. Other meetings may be provided for at regular times or be called by the Rector or in his absence by the Senior Warden, or, at the request of two Vestrymen, the Bishop of the Diocese may at his discretion call a meeting of the Vestry and preside at such meeting.

No grant shall be made nor shall any charge be imposed upon any consecrated church or chapel or any church or chapel which has been used solely for divine service belonging to the parish, except by the consent of a majority of the whole Vestry at any regular or special meeting, nor without the consent of the Bishop acting with the advice and consent of the Standing Committee of the Diocese. No real property held by the corporation shall be encumbered or sold without the consent of the Trustees of the Diocese of South Florida. All Conveyances shall be signed in the corporate name by the Rector if there be one, and by the Wardens under the common seal of the corporation.

The other privileges and duties of the Vestry, the Wardens, the Secretary and the Treasurer, shall be such as provided in the canons of the said Church in the United States of America and in the Diocese of South Florida.

7. The names of the officers who are to manage all the affairs of the corporation, until the first election under the charter, are: George M. Rutter, Rector; William B. T. Mook, Treasurer-Senior Warden; John M. Stanton, Junior Warden; Thomas C. Simpson, Secretary; William B. Probert; Melvin O. Brooks; Raymond P. Heath; W. K. Miller, Jr.; H. E. Winegar; and Charles Clark, Vestrymen.

8. The by-laws of the corporation (which must not be inconsistent with the canons aforesaid nor with this charter) are to be made, altered or rescinded by the Vestry.

9. The highest amount of indebtedness or liability to which the corporation may at any time subject itself shall never be greater than two-thirds of the value of the property of the corporation.

10. The amount in value of the real estate which the corporation may hold shall be 300,000.00 thousand dollars.

11. In case of the dissolution of the corporation, all of its property on the winding up of its affairs shall vest in the corporation known as The Trustees of the Diocese of South Florida, in trust to hold and convey the same to and for some existing or future congregation in the said City of Ormond Beach, Florida, of members of The Protestant Episcopal Church in the Diocese of South Florida, and to and for no other purpose.

12. This charter may be amended at a meeting of the lay members of the corporation, and if approved by a majority of the members present and voting, the amendment shall be submitted to the Bishop and to the Standing Committee of the Diocese, and if it be approved by the Bishop and the Standing Committee of the Diocese, it shall be and form part of the charter upon the consequent confirmation thereof by the court having jurisdiction and its recording according to law.
