

AMENDMENT TO THE  
THE ARTICLES OF INCORPORATION,  
OF  
CHASEWOOD OF JUPITER

(New language underlined; deleted language ~~struck through~~)

The Articles of Incorporation, Article VII, are hereby amended to read as follows:

ARTICLE VII - of the Articles of Incorporation

~~The affairs of the Association will be managed by a Board of Directors initially consisting of three directors who need not be members of the Association.~~

At such time as the members are entitled to elect all directors as set forth in S.718.301, Fla. Stat., and subject to the provisions of the Bylaws, the Board of Directors shall consist of ~~nine~~ seven directors who must be members of the Association.
