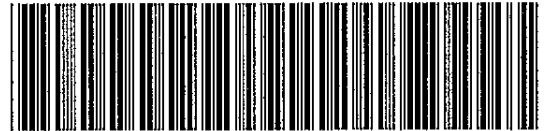



TO ARTICLES OF INCORPORATION
OF PROMENADE CONDOMINIUM OWNERS ASSOCIATION, INC.**

The undersigned officers of **Promenade Condominium Owners Association, Inc.**, a not for profit corporation organized and existing under the laws of the State of Florida, hereby certify that the following amendment to the Articles of Incorporation was approved by the members of the corporation at duly noticed and convened membership meetings held on February 17, 2005. The number of votes cast in favor of the adoption of the amendment was sufficient for approval under the terms of the Articles of Incorporation of the Association, and applicable law.

**ARTICLE IX
Amendments**

9.1 Amendments. Amendments to the Articles of Incorporation shall be proposed and adopted in the following manner:

.....

(b) A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by not less than thirty (30%) percent of the voting ~~interests requirements of the members~~ of the Association. To be adopted, the amendment must be approved by not less than seventy percent (70%) of the voting interests of the members participating in person, by proxy, or by written consent, at a duly noticed membership meeting at which a quorum of the membership is attained and in no event by less than a majority of all voting interests (57 of 112), of the votes of the entire membership. Members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the Secretary at or prior to the meeting.
