AMENDMENTS ADOPTED:

In order to update the Articles of Incorporation and to incorporate therein the recently adopted changes to the bylaws which were adopted by the Board of Trustees on April 23, 2008, the Board of Trustees and the membership hereby amend the Articles of Incorporation as follows:

1. ARTICLE V(a) third full paragraph is deleted and replaced with the following:

Trustees shall be nominated, elected, serve, resign and/or be removed from office pursuant to the provisions of the bylaws.

- 2. ARTICLE VIII(b) & (c) are deleted and replaced with the following:
- (b) Any person (1) completing an application for membership which acknowledges agreement to be bound by and support the Articles of Incorporation and the Bylaws; (2) paying the \$50.00 annual membership application donation; and (3) being approved for membership by the Board of Trustees is a Member of the Corporation for that fiscal year.
