ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE BAY VISTA ESTATES HOMEOWNERS' ASSOCIATION, INC.

Pursuant to the provisions of Chapter 617, Florida Statutes, the undersigned notfor-profit corporation adopts these Articles of Amendment to Articles of Incorporation, as follows:

- 1. The name of the corporation is The Bay Vista Estates Homeowner's Association, Inc.
- 2. The original Articles of Incorporation were filed with the Florida Secretary of State's Office on June 13, 1983.
- 3. These Articles of Amendment to Articles of Incorporation were duly adopted by the members on May 3, 2000, and the number of votes cast for the amendment was sufficient for approval.
- 4. These Articles of Amendment to Articles of Incorporation will become effective on the date of filing of the same with the Florida Secretary of State's Office.
- 5. Article X entitled "Indebtedness" of the Articles of Incorporation is hereby amended in its entirety to read as follows:

The highest amount of indebtedness or liability to which the Corporation, at any time, may subject itself shall be Fifty Thousand Dollars (\$50,000).

6. Article VIII entitled "Bylaws" of the Articles of Incorporation is hereby renamed "Amendments" and is amended in its entirety to read as follows:

The Corporation shall be governed by Bylaws as adopted by the voting members of the Corporation. An amendment to the Bylaws of the Corporation may be made in the manner set forth in the Bylaws.

An amendment to the Articles of Incorporation may be proposed either by a majority of the Board of Directors or by not less than one-third of the Members of the Corporation. Notice of the subject matter of a proposed amendment shall be included in the notice of a meeting at which the proposed amendment is to be considered. Approval of the proposed amendment shall be by not less than two-thirds of all Members of the Corporation. Members not present in person or by proxy at the meeting considering the amendment may express their approval in

writing, provided that such approval is delivered to the Secretary of the Corporation at or prior to the meeting.

7. Article XI entitled "Value of Property Held" of the Articles of Incorporation is hereby amended in its entirety to read as follows:

The amount and value of the property, real and personal, which the Corporation may hold shall be One Million Dollars (\$1,000,000.00).

8. Subsection 7 of Article III entitled "Powers and Procedures" of the Articles of Incorporation is hereby amended in its entirety to read as follows:

To impose assessments against the Members of the Corporation pursuant to the Bylaws of the Corporation and the Declaration of Covenants, Conditions and Restrictions for Bay Vista Estates.
