CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF PGA VILLAGE PROPERTY OWNERS' ASSOCIATION, INC.

The Articles of Incorporation of PGA Village Property Owners' Association, Inc. were recorded in the public records of St. Lucie County, Florida at OR Book 477, Page 2178. The Articles of Incorporation are amended as approved by the board of directors and by more than a majority of the members of the Association entitled to vote.

1. Article VII is amended to read as follows:

<u>ARTICLE VII</u>

The affairs of the corporation are to be managed by a Board of Directors, consisting of not less than 3 members and not more than 9 members, the exact number of which shall be determined by the By-Laws of the corporation. Members of the Board of Directors shall be elected at the annual meeting of the membership and shall serve three (3) year staggered terms. The Board shall appoint a President, Vice-President, Secretary, Treasurer and such other officers as may be provided by the By-Laws, who shall be charged with such day-to-day responsibilities as may be determined by the Board. Officers shall serve at the pleasure of the Board.

(The balance of Article VII remains unchanged.)

- 2. The foregoing amendment to the Articles of Incorporation was approved by more than a majority of the members of the Association entitled to vote.
- 3. All provisions of the Articles of Incorporation are confirmed and shall remain in full force and effect, except as specifically amended herein.
