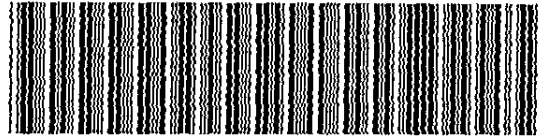

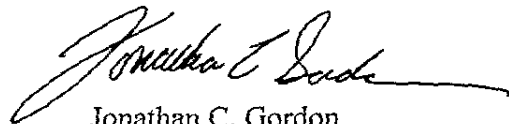
Dear Division of Corporations Personnel:

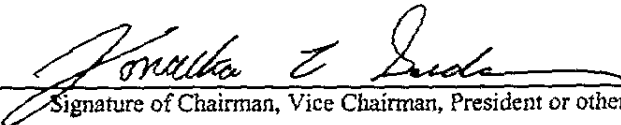
