#### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF AQUARINA COMMUNITY SERVICES ASSOCIATION , INC.

As used herein the following shall apply:

- A. Words in the text which are lined through with hyphens (----) indicate deletions from the present text.
- B. Words in the text which are <u>underlined</u> indicate additions to the present text.
- 1. Article IV.B of the Articles of Incorporation shall be amended to read as follows:

"IV

**POWERS** 

The powers of the Association shall include the power:

B. Transferring Property. To own, operate, lease, sell and tracereal and personal property whenever it proves necessary or convenient in the administering of the Common Properties or the payment of common expenses and with respect to the Aquarina Golf Course, purchase, acquire, mortgage, and grant security interests; and to grant easements and rights-of-way over property owned by it when necessary to enable utility or other services to service portions of the Aquarina Lands or as otherwise permitted by the Declaration."
