FIRST: Article VI is amended as follows (new language is indicated by <u>underscored</u> type. Deleted language is indicated by <u>struck through</u> type):

ARTICLE VI

Section 1. The affairs of the Corporation shall be managed and governed by a Board of Directors composed of not less than three two nor more than the number specified in the By-Laws. The Directors, subsequent to the first Board of Directors, shall be elected at the annual meeting of the membership, for a term of one year, or until their successors shall be elected and shall qualify.
