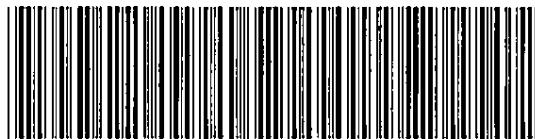

ARTICLES OF INCORPORATION OF
THE FLORIDA GOVERNMENT BAR ASSOCIATION, INC.

769474

ARTICLE I

NAME:

This association shall be known as the FLORIDA GOVERNMENT BAR ASSOCIATION, INC., and shall be referred to hereinafter as "the association".

ARTICLE II

PURPOSES:

The association, a corporation not for profit organized under the authority of Part I, Chapter 617, Florida Statutes, is formed to advance the science of jurisprudence, to promote reform in the law with emphasis on administrative law, to facilitate the administration of justice, to uphold the standard of integrity, honor, and courtesy in the legal profession, to encourage legal education, to cultivate a spirit of cordiality and brotherhood among the members of The Florida Bar employed in Florida government, and to pursue any other purpose authorized by the applicable laws of the State of Florida so long as no part of the income or assets of this corporation is distributed to the officers, directors or members thereof.

ARTICLE III

QUALIFICATION OF CORPORATE MEMBERS AND MANNER OF ADMISSION:

Section 1. Qualification of corporate members.--Any member of The Florida Bar in good standing who has been or is full-time employed in the executive, legislative, or judicial branch of Florida or Federal government shall be qualified for membership in the association.

Section 2. There shall be three classes of membership in the association as follows:

Subsection (a) ACTIVE MEMBERS.--Any member who selects the dues payment plan which includes all fees and charges shall be deemed an active member of the association.

Subsection (b) PARTICIPATING MEMBERS.--Any member who selects the dues payment plan which is exclusive of all other assessments or charges shall be deemed a participating member of

the association.

Subsection (c) HONORARY MEMBERS.--Any member of The Florida Bar in good standing who is a justice, judge, elected or appointed official of the State of Florida or the United States, or who has retired from employment in Florida government or Federal government and is not actively engaged in the practice of law, may become an honorary member of the association in the manner hereinafter provided, unless he shall request classification as an active or participating member in which event he shall be eligible to become an active or participating member.

Section 3. Privileges of membership.

Subsection (a) Active and participating members may vote upon any and all matters in said association, may hold office, and may perform any of the duties, functions and privileges in said association.

Subsection (b) Honorary members shall not vote or hold office in the association.

Subsection (c) All members shall have the privileges of the floor at all meetings of the association.

Section 4. Admission of members.

Subsection (a) Upon the beginning of corporate existence of the association, all persons who are currently members in good standing of the unincorporated Florida Government Bar Association shall be members of the incorporated association in a membership class equivalent to their current class in the unincorporated association. All other members shall be admitted as set out below.

Subsection (b) Application for membership shall be made either to the president of the association or to the Chairman of the Committee of Admissions. If made to the president of the association, he shall immediately thereafter transmit the application to the Chairman of the Committee on Admissions; the chairman of said committee shall then submit said application to the Committee on Admissions; and said committee shall make its report thereon with its recommendation to the association at its next regular meeting. The members of the association at such meeting shall thereupon vote on such

application. One negative vote in every five of those voting shall defeat an election for an active or participating membership. Such application for membership shall be in writing signed by the applicant, which application shall state whether the applicant is eligible for active, participating or honorary membership. The application for active or participating membership shall be accompanied by either cash or check for the current dues in said association.

Subsection (c) Persons qualified for honorary membership shall be elected upon the vote of a majority of those voting. Honorary members shall be exempt from dues but not from meal charges.

Subsection (d) Any member who ceases to be a member of The Florida Bar in good standing shall automatically cease to be a member of this association.

ARTICLE IV

TERM OF EXISTENCE:

The term of existence of the association shall be perpetual.

ARTICLE V

SUCCESSOR TO UNINCORPORATED FLORIDA GOVERNMENT BAR ASSOCIATION:

The association is hereby declared to be the successor to the unincorporated Florida Government Bar Association, and shall accept all assets and liabilities transferred to it by said unincorporated association. All contracts and agreements currently in force between the unincorporated association and any party whatsoever which are assigned to the incorporated association shall be accepted and shall continue in full force and effect.

ARTICLE VII

OFFICERS, STANDING COMMITTEES AND EXECUTIVE COUNCIL:

The affairs of the association shall be managed by a president, a vice-president, a secretary, a treasurer, and by an Executive Council composed of these officers plus three (3) persons elected by the membership. Officers and Executive Council members shall be elected at the June meeting by a majority of voting members in attendance and shall take office at the succeeding July meeting, and shall hold office for twelve (12) months or until their successors assume office, except that officers and Executive Council members shall be elected and installed at the first meeting following incorporation and shall hold office until the following July or until their successors assume office. When an office or Executive Council position falls vacant between elections, it shall be filled by the Executive Council.

ARTICLE VIII

IDENTIFICATION OF OFFICERS WHO SHALL SERVE UNTIL FIRST ELECTIONS UNDER ARTICLES OF INCORPORATION:

BYLAWS:

The Bylaws may be made, altered, or amended at any meeting on recommendation of the Executive Council or motion of any member by a vote of two-thirds of the active and participating members present.

ARTICLE XI

AMENDMENTS TO ARTICLES OF INCORPORATION:

Section 1. These articles may be altered or amended at any regular meeting on recommendation of the Executive Council, by a vote of two-thirds of the active and participating members present, or without such recommendation by a vote of three-fourths of the active and participating members present.

Section 2. Before any such alteration or amendment shall be voted upon, the same shall be submitted to a prior regular meeting of the association. The proposed alteration or amendment so submitted shall be voted upon at the next regular meeting of the association, unless another regular meeting of the association is designated by vote of the association to be the regular meeting of the association, at which proposed alteration or amendment is to be voted upon by the association.

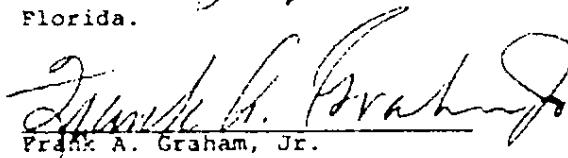
ARTICLE XII

DISSOLUTION:

In the event of the dissolution of this corporation and the winding up of its affairs, all assets shall be distributed to the

AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
FLORIDA GOVERNMENT BAR ASSOCIATION, INC.

(The date of filing of the original articles of incorporation of Florida Government Bar Association, Inc. by the Secretary of State was July 20, 1983. All amendments included in these Amended and Restated Articles of Incorporation were duly adopted by a vote of the members of the corporation on July 16, 1990, in conformity with the original articles of incorporation and pursuant to subsection 517.0201(4), Florida Statutes (1989); there is no discrepancy between the articles of incorporation as heretofore amended and the provisions of these Amended and Restated Articles of Incorporation other than the inclusion of amendments adopted pursuant to subsection 517.0201(4), Florida Statutes (1989), and the omission of matter of historical interest. Amended provisions are identified by the use of an asterisk (*). In addition to the omission of matters of historical interest, Articles VII, OFFICERS, STANDING COMMITTEES AND EXECUTIVE COUNCIL, and X, BYLAWS, of the original articles of incorporation, have been amended by being deleted in their entirety.)

ARTICLE I

NAME:

This association shall be known as the FLORIDA GOVERNMENT BAR ASSOCIATION, INC., and shall be referred to hereinafter as "the association".

* ARTICLE II

DURATION:

The period of duration of the association is perpetual unless dissolved according to law.

* ARTICLE III

PURPOSES:

The association is formed to advance the science of jurisprudence, to promote reform in the law with emphasis on government practice and administrative law, to facilitate the administration of justice, to promote the standards of integrity, honor and courtesy in the legal profession, to encourage legal education, to cultivate a spirit of cordiality and unity among the members of The Florida Bar employed in Florida government, and to pursue any other purpose authorized by the applicable laws of the State of Florida so long as no part of the income or assets of this association is distributed to the officers, directors or members thereof.

* ARTICLE IV

QUALIFICATIONS FOR MEMBERS AND THE MANNER OF THEIR ADMISSION:

The qualifications for members and the manner of their admission shall be regulated by the constitution and bylaws of the association.

* ARTICLE V

CONDUCT OF THE AFFAIRS OF THE ASSOCIATION:

The conduct of the affairs of the association shall be as provided for in the constitution and bylaws of the association.

* ARTICLE VI

AMENDMENTS TO ARTICLES OF INCORPORATION:

Section 1. These articles may be amended at any regular meeting on recommendation of the Executive Council (or such other name by which the governing body of the association is then known), by a vote of two-thirds of the active and participating members voting, or without such recommendation by a vote of three-fourths of the regular members voting.

Section 2. Before any such amendment shall be voted upon, the same shall be submitted to a prior regular meeting of the association. The proposed amendment so submitted shall be voted upon at the next regular meeting of the association, unless a motion proposing that the requirement for such delay be waived, or that such vote be postponed until a later regular meeting of the association, is made, seconded and adopted by a majority vote of the members present, in which case such vote shall be taken at the meeting at which the proposed amendment was submitted or at such later regular meeting, as applicable.

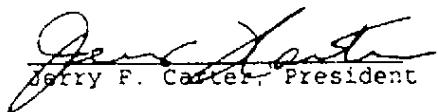

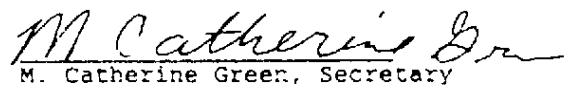
DISSOLUTION:
