ARTICLES OF INCORPORATION

OF

GARDEN LAKES COMMUNITY ASSOCIATION, INC.  
A Corporation Not for Profit

The undersigned hereby forms a corporation not for profit under Chapter 617, Florida Statutes and certifies as follows:

ARTICLE I. NAME

The name of the corporation shall be "Garden Lakes Community Association, Inc.". For convenience the corporation shall herein be referred to as the "Community Association".

ARTICLE II. PURPOSE

2.1 Purpose: The purpose for which the Community Association is organized is to provide an entity for the maintenance, preservation, management and control of the Common Property located within Garden Lakes, a planned community located in an unincorporated area of Manatee County, Florida, same to be in accordance with the "Declaration of Covenants, Conditions and Restrictions for Garden Lakes", herein called the "Covenants", which is to be recorded in the Public Records of Manatee County, Florida, as same may be amended. The Community Association shall have the further purpose of promoting the health, safety and welfare of the owners and residents of Garden Lakes, consistent with the Covenants, these Articles and the By-Laws of the Community Association, and the Condominium Declarations and other documents relating to the component communities of Garden Lakes. The Community Association is not incorporated for the purpose of managing or operating any condominium that may be a component community of Garden Lakes, nor shall it have the purpose of serving as a Condominium Association under Chapter 718, Florida Statutes.

ARTICLE III. POWERS

3.1 Common Law and Statutory Powers: The Community Association shall have all of the common law and statutory powers of a corporation not for profit not in conflict with these Articles or the Covenants, other than those powers expressly reserved by the Condominium Act to any Condominium Association operating a condominium within Garden Lakes or to the unit owners in any such condominium.

3.2 Specific Powers: The Community Association shall have all of the powers and duties set forth in the Covenants, as amended from time to time, except as validly limited by these Articles and by said Covenants, and all of the powers and duties reasonably necessary to own and operate the Common Property of Garden Lakes pursuant to said Covenants and to perform the maintenance, administrative, managerial and other functions for Garden Lakes as provided in said Covenants, as they may be amended from time to time, including but not limited to the following:

- (a) To make and collect assessments against members as residential unit owners to defray the cost of the common expenses of Garden Lakes as provided in the Covenants.
- (b) To use the proceeds of assessments in the exercise of its powers and duties.
- (c) To accept, hold title to, own, purchase, acquire, replace, improve, manage, maintain and administer the use of the Common Property of Garden Lakes in accordance with the Covenants.

- (d) To purchase insurance upon the Common Property and for the protection of the Community Association and its members.
- (e) To reconstruct improvements to the Common Property after casualties and further to improve the Common Property in accordance with the Covenants.
- (f) To adopt and amend reasonable rules and regulations respecting the use of the Common Property in accordance with the Covenants.
- (g) To enforce by legal means the provisions of the Covenants, the By-Laws of the Community Association, and regulations duly adopted by the Community Association.
- (h) To furnish or otherwise provide for private security, fire protection or such other services as the Board of Directors in its discretion determines necessary or appropriate.
- (i) To pay any real and personal property taxes and other charges assessed against the Common Property unless same are separately assessed to the owners.
- (j) To obtain all required utility and other services for the Common Property.
- (k) To establish, maintain, repair, replace, manage and administer community service systems for the common use, benefit and enjoyment of the owners and residents of Garden Lakes in accordance with the Covenants.
- (l) To negotiate and contract for such materials and services for the benefit of all or any part of the residential unit owners who may subscribe to or elect to accept such materials or services as agent on behalf thereof, in accordance with the Covenants, and to negotiate and contract for such materials and services as agent for and on behalf of those associations operating component communities as may be requested and agreed to by such organizations, including but not limited to the operation and maintenance of any one or more community service systems.
- (m) To borrow money and to pledge assets of the Community Association as security therefor pursuant to the Covenants.
- (n) To establish a special tax district for the performance of all or a part of the maintenance or other functions provided by the Covenants as the responsibility of the Community Association.
- (o) To employ personnel for reasonable compensation to perform the services required for the proper carrying out of the Community Association responsibilities.
- (p) To prepare and maintain such parts of Garden Lakes as may be provided in the Covenants.
- (q) To enter into agreements whereby it acquires additional common property, including but not limited to, leasehold memberships and other possessory or use interests in lands or facilities, whether or not contiguous to Garden Lakes, intended to provide for the enjoyment, recreation or other use benefits of residential unit owners.

(r) To exercise such further authority as may be reasonably necessary to carry out each and every of the obligations of the Community Association set forth in the Covenants, provided such authority is not expressly reserved to a Condominium Association or the owners of residential units in such Condominium located within Garden Lakes by the Condominium Act.

**3.3 Assets Held in Trust:** All funds and the title of all properties acquired by the Community Association and the proceeds thereof shall be held in trust for the members, in accordance with the Provisions of the Covenants, these Articles and the By-Laws of the Community Association.

**3.4 Limitation on Exercise of Power:** The powers of the Community Association shall be subject to and shall be exercised in accordance with the provisions of the laws of the State of Florida, the Covenants, these Articles and the By-Laws of the Community Association.

#### ARTICLE IV. MEMBERS

**4.1 Members:** The members of the Community Association shall consist of all of the record owners of residential units in Garden Lakes subject to the Covenants

**4.2 Change of Membership:** Change of membership in the Community Association shall be established by the recording in the Public Records of Manatee County, Florida, of a deed or other instrument establishing a change of record title to a residential unit in Garden Lakes. The owner designated in such instrument shall thereupon become a member of the Community Association and the membership of the prior owner shall thereupon be terminated, as provided in the By-Laws.

**4.3 Limitation on a Transfer of Shares or Assets:** The share of a member in the funds and assets of the Community Association cannot be assigned, hypothecated or transferred in any manner except as an appurtenance to the member's residential unit.

**4.4 Voting:** The owner of each residential unit shall be entitled to one vote as a member of the Association; provided, however, that the Developer shall, during development, be entitled to the number of votes as provided in the Covenants. The manner of exercising voting rights shall be determined by the By-Laws of the Community Association. Owners owning more than one residential unit shall be entitled to one vote for each residential unit owned. Voting rights shall be subject to such provisions for delegation of voting rights and the granting of irrevocable proxies as may be provided in the Covenants and the By-Laws.

#### ARTICLE V. DIRECTORS

**5.1 Board of Directors:** The affairs of the Community Association shall be managed by a Board of Directors consisting of an odd number of members determined from time to time in accordance with the By-Laws. In no event shall the Board of Directors consist of fewer than three Directors. Directors shall be members of the Community Association except as otherwise provided.

**5.2 Election of Directors:** Directors of the Community Association shall be elected at the annual meeting of the members, in the manner provided by the By-Laws. Directors may be removed and vacancies on the Board shall be filled in the manner provided by the By-Laws.

**5.3 First Board of Directors:** The names and addresses of the initial Board of Directors, who have been selected by the Developer and who shall serve until their successors are elected and have qualified, or until they resign or are removed, are as follows:

The initial Directors designed by Developer herein, and any Directors subsequently designated or appointed or elected by Developer, need not be members of the Community Association. All other Board members shall be members.

#### ARTICLE VI. OFFICERS

6.1 Officers: The affairs of the Community Association shall be administered by a President, Vice President, Secretary, Treasurer and such other officers as may from time to time be created by the Board of Directors as permitted by the By-Laws. Officers shall be elected by the Board of Directors at its first meeting following the annual meeting of the Community Association and shall serve at the pleasure of the Board. Offices may be combined as provided in the By-Laws. The names and addresses of the officers who shall serve until their successors are designated by the Board of Directors are as follows

#### ARTICLE VII. INDEMNIFICATION

7.1 Indemnification: Every director and every officer of the Community Association shall be indemnified by the Community Association against all expenses and liabilities, including legal fees, reasonably incurred by, or imposed upon him in connection with any proceeding or the settlement of any proceeding to which he may be a party, or in which he may become involved by reason of his being or having been a Director or officer of the Community Association, whether or not he is a Director or officer at the time such expenses are incurred, except when the Director or officer is adjudged guilty of willful and wanton misfeasance or malfeasance in the performance of his duties; provided that in the event of a settlement, the indemnification shall apply only when the Board of Directors approves such settlement and reimbursement as being for the best interests of the Community Association. The foregoing right of indemnification shall be in addition to and not exclusive of all other rights to which such Director or officer may be entitled.

7.2 Insurance: The Board of Directors of the Community Association may purchase liability insurance to insure all Directors, officers or agents, past and present, against all expenses and liabilities as set forth above. The premiums for such insurance shall be paid by the members of the Community Association as part of the common expenses.

#### ARTICLE VIII. BY-LAWS

8.1 By-Laws: The first By-Laws of the Community Association shall be adopted by the Board of Directors, and may be altered, amended or rescinded by a majority of the Board, except as otherwise may be provided by the By-Laws and the Covenants.

#### ARTICLE IX. AMENDMENTS

9.1 Amendments: These Articles may be altered, amended or modified upon the affirmative vote of the owners of a majority of the residential units in Garden Lakes. Amendments may be proposed by resolution of the Board of Directors or by the owners of any fifteen residential units. Provided, however, that no amendment affecting the Developer, or its successors or assigns as the Developer of Garden Lakes, as defined in the Covenants, shall be effective without the prior written consent of the Developer, its successors or assigns as such Developer. Provided, further that no amendment shall make any change in the qualification for membership nor the voting rights of members without the approval of all members. No amendment shall be made which is in conflict with Covenants, or which discriminates against any component community of Garden Lakes or any class of owners of residential units within Garden Lakes.

#### ARTICLE X. EXISTENCE

The term of the Community Association shall be perpetual.

#### ARTICLE XI. SUBSCRIBER
