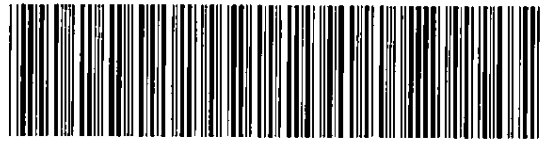

ARTICLES OF INCORPORATION

OF

NEW JERUSALEM BAPTIST CHURCH, INC. OF POMPANO BEACH

A Corporation Not For Profit

In order to form a Corporation Not For Profit under and in accordance with Chapter 617 of the Florida Statutes, I, the undersigned subscriber, being a natural person over the age of eighteen (18) years and otherwise competent to contract, hereby form a Corporation Not For Profit for the purposes and with the powers hereinafter set forth, and to that end, I do, by these Articles of Incorporation, certify and set forth the following:

ARTICLE I - NAME

The name of this Corporation shall be NEW JERUSALEM BAPTIST CHURCH, INC. OF POMPANO BEACH

ARTICLE II  
PURPOSE OF CORPORATION

The purposes for which the Corporation are to be formed are for religious purposes in accordance with Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or may hereafter be amended. More specifically, the purposes of this corporation are the dissemination of the gospel of Jesus Christ, and for the edification, encouragement and support of believers in the gospel; and

(a) to take and hold by bequest, devise, gift, grant, purchase, lease or otherwise any property, real, personal, tangible or intangible, or any undivided interest therein, without limitation as to amount or value; and

(b) to sell, convey or otherwise dispose of any such property and to invest, reinvest or deal with the principal or the income thereof in such manner as, in the judgment of the directors, will best promote the purposes of the Corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, this Certificate

of Incorporation, by By-Laws of the Corporation, or any laws applicable thereto; and

(c) to borrow money upon and pledge or mortgage any such property for any purpose for which it is organized, and to issue notes, bonds or other forms of indebtedness to secure any of its obligations; and

(d) to carry on any activity and to deal with and expend any property or income therefrom for any of the foregoing purposes without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, the Articles of Incorporation, by By-Laws of the Corporation, or any other limitations as are prescribed by law, provided that no such activity shall be such as is not permitted by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or any corresponding future provision of the Revenue Code, and provided further that no part of the net earnings of this Corporation shall inure to the benefit of any member or private individual and no member, director or officer of the Corporation shall receive any pecuniary benefit from the Corporation, except such reasonable compensation as may be allowed for services actually rendered to the Corporation affecting one or more of its purposes as permitted under the Florida Corporations Not For Profit Law; and

(e) the corporation shall have all of the powers set forth in Section 617.021, Fla. Stat.; and

(f) to do any other act or thing incidental to or connected with the foregoing purposes, or in advancement thereof, either directly or as agent for or with other persons, associates or corporations, but not for the pecuniary profit or financial gain of its directors or officers as set forth above, nor for any purpose or activity not permitted to be carried on by a corporation exempt from Federal income taxation under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now

exist or may hereafter be amended, or by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 and its regulations as they now exist or may hereafter be amended.

ARTICLE III  
QUALIFICATION OF MEMBERS

The authorized number, qualifications and manner of admission of members of this Corporation, the different classes of membership, if any, the property, voting and other rights and privileges of members, the liability of members for dues or assessments and the method of collection thereof, and the termination and transfer of membership shall be set forth in the By-Laws of this Corporation. Furthermore, notwithstanding anything to the contrary contained herein or in the By-Laws, membership shall only be granted upon the approval of a majority of the Board of Directors of the Corporation at a particular given time.

ARTICLE IV - TERM

This Corporation shall have perpetual existence.

ARTICLE V - SUBSCRIBER

ARTICLE VI - OFFICERS

The following individuals shall serve as Officers in their respective capacities as indicated next to their names, of the Corporation until the first election of the Corporation takes place. Said first election shall take place at a meeting on November 7, 1983. Thereafter the officers shall be elected at an Annual Meeting held the First Monday of November of each calendar year.

ARTICLE VII  
BOARD OF DIRECTORS

The initial Board of Directors of the Corporation shall be composed of five (5) Directors, and their names are as follows: REV. JAMES A. LATHAM; REV. WALTER CAMPBELL; ROGER PITTS; CORA SMITH; and HOMER RANDOLPH.

Said Directors shall serve until the First Meeting of Members of the Corporation, at which Meeting a majority of the Members may elect, by a plurality vote, new Directors and/or a different number of Directors. Notwithstanding anything to the contrary, this Corporation shall have no less than three (3) Directors nor more than ten (10) Directors at any particular time.

ARTICLE VIII  
BY-LAWS

The By-Laws of this Corporation shall be hereinafter adopted at the First Meeting of a quorum of the Board of Directors by a majority of same at such meeting. Such By-Laws may be amended or repealed, in whole or in part, by the Members or the Directors in the manner provided therein. Any amendments to the By-Laws shall be binding upon all Members of this Corporation.

ARTICLE IX  
AMENDMENT TO ARTICLES OF INCORPORATION

Amendments to these Articles of Incorporation shall be proposed by a Resolution adopted by the Board of Directors and presented to a quorum of Members for their vote. Amendments shall be adopted by a vote of at least two-thirds of a quorum of Members of the Corporation:

ARTICLE X  
DISSOLUTION

Upon the dissolution or other termination of the Corporation, no part of the property of the Corporation or any of the proceeds shall be distributed to or inure to the benefit of any of the

members of the Corporation, but all such property and proceeds, subject to the discharge of valid obligations of the Corporation, and to the applicable provisions of Chapter 617, Part 1, Corporations Not for Profit, of the Florida Statutes as amended from time to time, shall be distributed as directed by a majority of the members of the Corporation among one or more corporations, trusts, community chests, funds or foundations organized and operated exclusively for religious, charitable, scientific, literary or educational purposes, no part of the net earnings of which inure to the benefit of any private shareholder, or to other entities of the type which qualify for Federal Income Tax exemption under Section 501(c)(3) of the Internal Revenue Code of 1954.

ARTICLE XI  
MANAGEMENT

The Corporation shall be managed by the Officers in accordance with the By-Laws, and the Officers named herein shall serve until the first election takes place, and thereafter in accordance with the By-Laws.

ARTICLE XII  
POWERS

This Corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida; provided, however, that this Corporation is not empowered to engage in any activity that in itself is not in furtherance of its purposes as set forth in these Articles of Incorporation.

ARTICLE XIII
