This firm has the pleasure of representing Deerfield Beach House Condominium Association, Inc. Earlier this year it was determined that a prior manager of the Association failed to pay the annual dues for the Association in 2009, resulting in the involuntary dissolution of the nonprofit community association. In an effort to hide her error, the manager of the Association at the time formed a new entity, which is a violation of the rules of the Division of Land Sales.

Upon discovering this error, the Board of Directors of the Association voluntarily dissolved the improper entity formed under the same name by the former manager, and now wishes to reinstate the original corporation. To complete this task we are asking that you release the name of the recently dissolved entity to allow reinstatement of the original Association. Doing so will allow us to correct the errors of the former manager, so that the Association comes into compliance with the rules of the Division of Land Sales.

In speaking to the Division of Corporations on the telephone, we have been told that this is possible with a letter explaining the circumstances, especially since the officers and directors are the same and have been the same for both the original entity which was dissolved a couple of years ago, and the most recent entity which was voluntarily dissolved, along with a properly completed reinstatement form submitted by mail.

The reinstatement fee of \$175.00, and annual report fees for the years 2009, 2010, 2011, and 2012 of \$61.25 per year, totals \$420.00. The check for such amount is enclosed together with the completed reinstatement form. Please review the
