AMENDMENT TO THE ARTICLES OF INCORPORATION SECREFARY OF STATE

MIDWEST MUTUAL INSURANCE COMPANY

NOW, on this 16th day of January, 1998, at the regularly scheduled Annual Meeting of the members of Midwest Mutual Insurance Company, at which a quorum of the members were present, either in person or by proxy, the following amendments, after having been first duly recommended for adoption by the Board of Directors of the Company, were adopted by a majority vote:

1. Article I shall be amended to read:

The name of the corporation shall be Guidant Specialty Mutual Insurance Company.

2. Article VII, Section 3, shall read:

At all annual meetings or special meetings of the members, the members present at said meeting, either in person or represented by proxy, shall constitute a quorum for the election of directors and for the transaction of any business that may be legally acted upon at such meeting; but in no event shall a quorum consist of less than the number of authorized directors, plus one.

3. Article VIII, Section 13, shall read:

The regular annual meeting of the Board of Directors shall be held on the second Thursday of February each year; and the Board of Directors shall have the power to hold its meetings, either regular or special, with the exception of the regular annual meeting, within or without the State of Iowa, at such places as may be designated by the By-laws or by resolution of the Board.
