The following a corporation	g Restated Articles of Incorporation of <u>WISCONSIN NATIONAL LIFE INSURANCE COMPANY</u> originally organized on January 1, 1908 under Chapter 611 of the Wisconsin Statutes
and another	pursuant to the authority and provisions of Chapter 180 of the Wisconsin Statutes, supersede and take the existing articles of incorporation and any amendments thereto:
Article 1.	The name of the corporation is: HumanaDental Insurance Company
Article 2.	The corporation shall have authority to issue: 300 shares of \$25,000.00 par value common stock.
