**CERTIFICATE OF AMENDMENT  
OF THE  
CHARTER  
OF  
AVIVA LIFE AND ANNUITY COMPANY OF NEW YORK**

Pursuant to the provisions of Section 1206 of the New York Insurance Law and Section 805 of the New York Business Corporation Law, the undersigned, Guy Hudson Smith III and Richard C. Cohan, Jr., being, respectively, the President and the Executive Vice President, General Counsel and Secretary of Aviva Life and Annuity Company of New York (the "Company"), hereby certify as follows:

- FIRST: The name of the Company is Aviva Life and Annuity Company of New York.
- SECOND: The Charter of the Company was filed with the New York Insurance Department on December 27, 2007.
- THIRD: The amendment to the Charter of the Company affected by this Certificate of Amendment is to amend Section 1.01 to change the name of the Company effective March 3, 2014.
- FOURTH: Section 1.01 of the Charter is hereby amended and restated in its entirety to read as follows:
- "1.01. The name of the corporation shall be Athene Life Insurance Company of New York."
- FIFTH: The foregoing amendment to the Charter of the Company was authorized by the resolution of the Board of Directors of the Company, followed by action of the sole shareholder of the Company, each on December 5, 2013, the amendment to Section 1.01 to be effective March 3, 2014.
