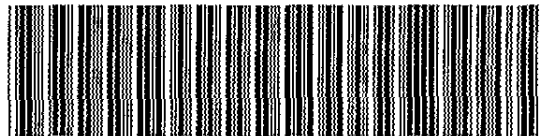

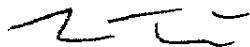

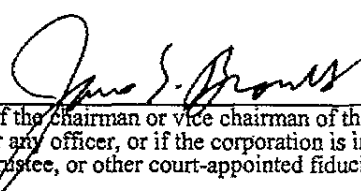

I also certify that by Articles of Amendment filed here October 16, 1918, the name of said corporation was changed to Sanford Riley Stoker Co.

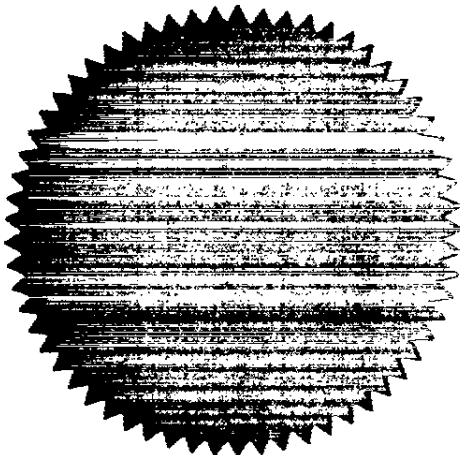
I further certify that by Articles of Amendment filed here December 27, 1924, the name of said corporation was changed to Riley Stoker Corporation.
