





#### PLAN AND AGREEMENT OF MERGER

PLAN AND AGREEMENT OF MERGER (the "Merjer") dated as of April 30, 1982, by and between BURNUP & SIMS, INC., a Florida corporation ("Florida") and a wholly-owned subsidiary of Burnup & Sims Inc., a Delaware corporation, and BURNUP & SIMS INC., ("Burnup") sometimes hereinafter referred to as the "Constituent Corporations".

#### RECITALS

- A. Florida was incorporated in the State of Florida on May 3, 1971. Its principal office is at 4047 Okeechobes Boulevard, West Palm Beach, Florida and its authorized capital stock consists of 10,000 shares of Common Stock, \$1.00 par value (the "Florida Common"), of which \$,065 shares are issued and outstanding and fully entitled to vote, all being owned by Burnup.
- B. Burnup was incorporated in the State of Del Fare on July 26, 1968. Its principal office is at 1333 Sough University Drive, Fort Lauderdale, Florida.
- have approved the Merger Agreement and deem it advisable and for the benefit of their respective corporations that Florida merge with and into Burnup on the terms and conditions hereinafter set forth (the "Merger").

#### ARTICLE ONE

#### Principal Terms of the Merger

section 1.01. Marger. At the effective time of the Mergur (as hereinafter defined), Florida shall merge into Burnup, which shall be the Surviving Corporation, on the terms and conditions hereinafter set forth.

Section 1.02. Effective Time of the Merger. The Merger shall become effective as of the date and time of the filing of the Articles of Merger with the Secretaries of State of the States of Delaware and Florida, and such date and time is herein referred to as the "Effective Time of the Merger."

#### ARTICLE TWO

### Conversion, Cancellation and Payment for Shares


Section 2.01. Cancellation of Shares of Florida

Common. Each share of Florida Common, issued and outstanding
at the Effective Time of the Merger, shall by virtue of the

Merger be cancelled or otherwise extinguished. The issued and
outstanding shares of Burnup shall remain issued and outstanding.

Section 2.02. Effect of the Merger. Upon the Merger becoming effective, the separate existence of Florida shall (except insofer as it may or must be continued by statute) cease, and it shall be merged with and into Rurnup, which shall possess all the rights, privileges, powers and franchises as well of a public and of a private nature, and be subject to all the restrictions, disabilities and duties of each of the Constituent Corporations; and all and singular the rights, privileges, powers and franchises of each of the said Corporations, and all property, real, personal and mixed, and all debts due to any of the Constituent Corporations on whatever account, and other choses in action or belonging to each of such Corporations shall be vested in Burnup; and all property, rights, privileges, powers and franchises, and all and every other interest shall be thereafter as effectually the property of Burnup, as they were of the Constituent Corporations, and the title to any real estate vested by deed or otherwise in any of the Constituent Corporations shall not revert or be in any way impaired; but all rights of creditors and all liens upon any property of any of the Constituent Corporations shall be preserved unimpaired, and all debts, liabilities and duties of the Constituent Corpora tions shall thenceforth attach to the said Burnup and may be enforced against it to the same extent as if said debts, liabilities and duties had been incurred or contracted by it.

Section 2.03. No Further Transfers. After the Effective Time of the Herger, the stock transfer books of Florida shall be closed.



## ARTICLE THREE

Section 3.01. Filing with the State of Delaware.

Subject to the provisions of Article Four, the Constituent

Corporations shall cause a Certificate of Merger to be filed

with the Secretaries of State of the States of Delaware and


Florida. The Certificate of Incorporation of Burnup shall be

the Certificate of Incorporation of the surviving Corporation.

#### ARTICLE FOUR

#### Miscellaneous

Section 4.01. Further Assurances. If, at any time after the Effective Time of the Merger, Burnup shall consider that any assignments, transfers, deeds or other assurances in law are necessary or desirable to vest, perfect or confirm, of record or otherwise in Burnup title to any property or rights of either of the Constituent Corporations, each Constituent Corporation and its officers and directors shall execute and deliver such documents and do all things necessary and proper to vest, perfect or confirm title to such property or rights in Burnup, and the officers and directors of Burnup are hereby fully authorised in the name of either of the Constituent Corporations or otherwise to take any and all such actions.



IN WITNESS WHEREOF, Florida and Burnup, pursuant to authority duly given by their respective Boards of Directors, have caused this Merger Agreement to be executed in accordance with the laws of the States of Florida and Delaware, and their respective corporate seals to be affixed hereto, as of the day and year first above written.


