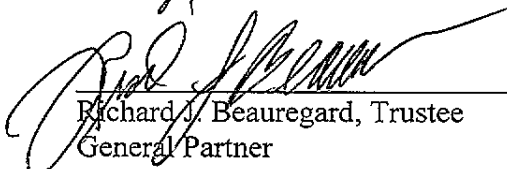

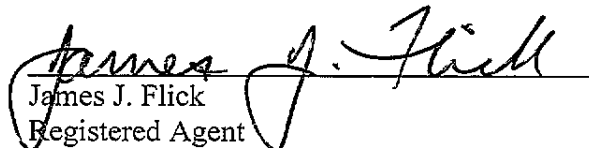
1. The name of the Partnership is "The RJB Family Limited Liability Partnership".
