If the entity or the person responsible for filing the above referenced entity's uniform business report did not receive the first notice in a timely fashion and wishes to have the \$500 penalty fee (per year) and administrative revocation abated, simply attach a written statement to that effect to the enclosed form and return it to this office with the appropriate fees.

Otherwise, the entity must return the enclosed form with the appropriate filing fees and the \$500 penalty fee for each year due this office.

Please return your document, along with a copy of this letter, within 60 days or your filing will be considered abandoned.


