9. <u>Miscellaneous Provisions</u>

1. The purpose for which the Limited Partnership is organized is limited solely to (A) owning, holding, selling, leasing, transferring, exchanging, operating and managing the premises located at 176 W. Street Road, Feasterville, Pennsylvania ("Premises"), (B) entering into certain Notes, mortgages, deeds of trust and other related loan documents with Mellon United National Bank, a national banking association, its successors and/or assigns ("Lender") in connection with the making of those certain loans in the aggregate principal sum of \$24,250,000.00 ("Loans"), (C) refinancing the Premises in connection with a permitted repayment of the Loans, and (D) transacting any and all lawful business for which a Limited

Partnership may be organized under the laws of the state of Florida that is incident, necessary and appropriate to accomplish the foregoing.

- 2. The Limited Partnership's ability to incur indebtedness other than the Loans is limited to incurring liabilities in the ordinary course of its business that are related to the ownership and operation of the Premises.
- 3. The Limited Partnership's ability to enter into transactions with affiliates is limited only to transactions on an arm's length basis and on commercially reasonable terms.
