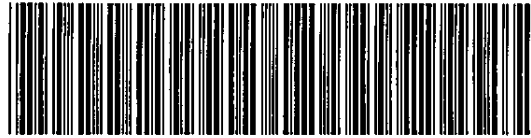

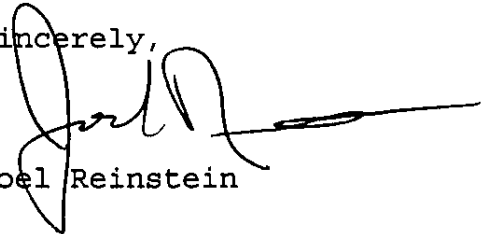

CERTIFICATE OF AMENDMENT TO
