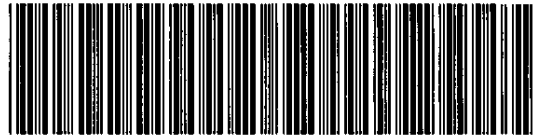



The undersigned, desiring to dissolve a limited partnership under the Florida Revised Uniform Limited Partnership Act of 2005, hereby certifies:


1. The name of the limited partnership is JDO LIMITED PARTNERSHIP NO. THREE, LLLP (the "Partnership").
