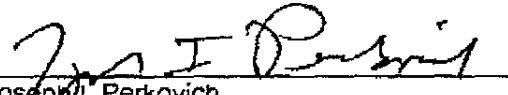
- A. The name of the limited partnership is Horse Creek Properties, Ltd., which shall be changed as provided below.
