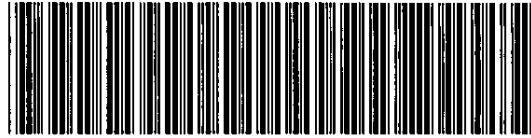

**STATEMENT OF CORRECTION OF  
CERTIFICATE OF LIMITED PARTNERSHIP OF
