Enclosed please find a Limited Partnership Reinstatement form and a check in the amount of \$877.50, representing two years of filing fees (2003 - 2004).

We are writing today to respectfully request that you consider waiving the reinstatement penalty fees for this entity. When we received your original letter of December 2, 2002 (copy enclosed) confirming certification of our initial filings, we did not believe that the initial annual report would be due last year. Specifically, your letter indicates that the "report will be due this office between January 1 and May 1 of the year *following the calendar year* (emphasis added) of the file date." Because of the date of your letter, we understood such language to mean that our first calendar year would be 2003, thus our initial annual report would be due by May 1, 2004.
