("Lender") to the Borrowers pursuant to that certain Loan Agreement dated on or about 100e 10, 2005 by and among Lender and the Borrowers (the "Loan Agreement"), as may be amended from time to time. When the Borrowers are no longer obligors under the Loan. Paragraphs 7.1, 7.2, 7.3 and 7.4 shall no longer remain in effect and shall be null and void; provided, that until such time, Paragraphs 7.1, 7.2, 7.3 and 7.4 shall govern over any provision in this Certificate of Limited Partnership.
