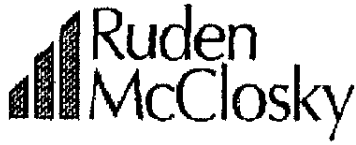

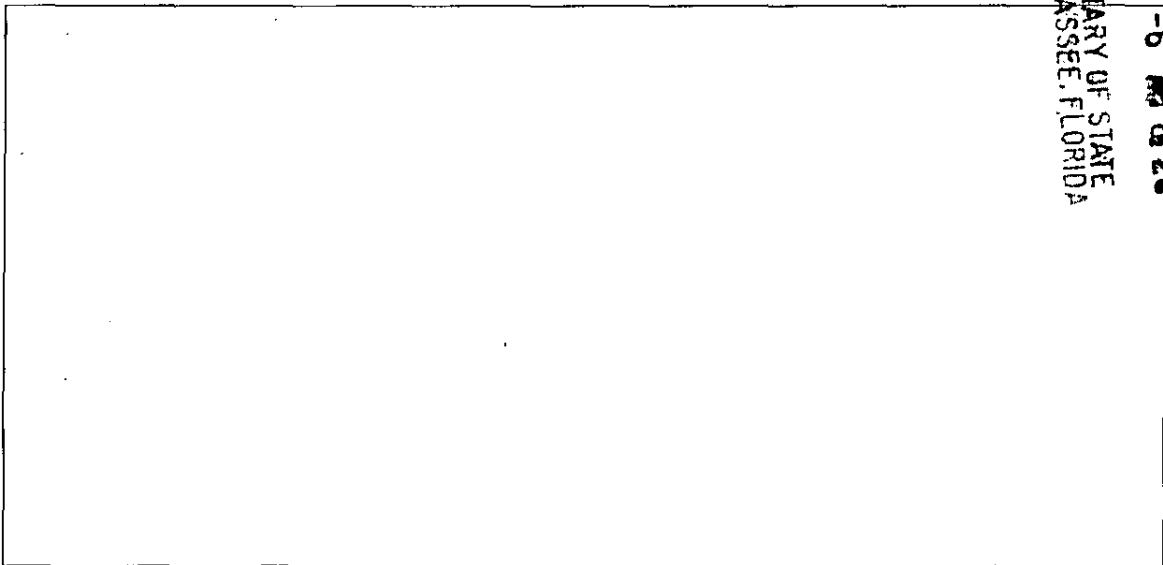

CERTIFICATE OF LIMITED LIABILITY LIMITED PARTNERSHIP

7400 Associates, Ltd. was originally organized by the filing of its certificate of limited partnership on February 9, 1976 and was assigned Document #A04757. This Second Amended and Restated Certificate of Limited Liability Limited Partnership amends and restates the Amended and Restated Certificate of Limited Partnership filed on October 5, 2006. The amendments reflect: (i) the automatic removal of Edward S. Nacht as general partner upon his death; (ii) the admission of Jason Hirsch as a general partner (iii) the determination to convert the limited partnership to a limited liability limited partnership; and (iv) the new name, 7400 Associates LLLP to reflect its new status as a limited liability limited partnership, replacing the prior name of 7400 Associates, Ltd.

1. The name of the limited partnership is 7400 ASSOCIATES, LLLP.
2. The street and mailing address of the designated office of the limited partnership is 7400 Northwest 5<sup>th</sup> Street, Plantation, Florida 33317.
3. The registered agent of the limited partnership is Denis P. Trupkin, and his office address is 7400 Northwest 5<sup>th</sup> Street, Plantation, Florida 33317.

The current name of the limited partnership, 7400 Associates, LLLP, is first being designated by this Certificate; the name of the limited partnership from its inception on February 9, 1976 through to the filing of this Certificate was 7400 Associates, Ltd.

Upon such filing, the initial certificate of limited partnership and any amendments or supplements to it, shall be superseded, but the original effective date of formation shall remain unchanged.
