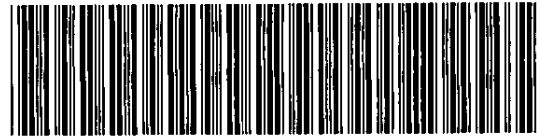

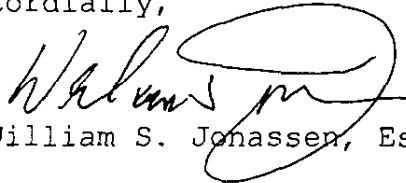

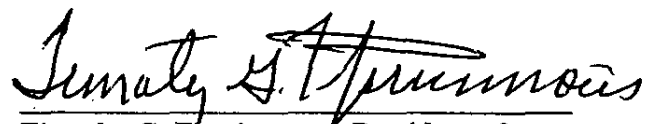
**CERTIFICATE OF AMENDMENT TO THE CERTIFICATE
OF LIMITED PARTNERSHIP OF
