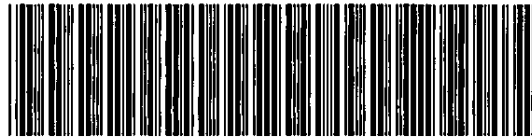

**FURTHER RESOLVED, THAT** there are no suits pending against the Partnership in any court;

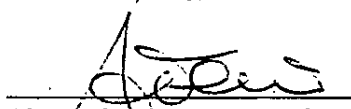
