Pursuant to the provisions of Florida Statutes §620.8907, **LEXMERGE PARTNERSHIP 20222**, a general partnership existing under the laws of the State of Florida (the "Merged Entity"), and **SHADOWOOD APARTMENTS, LTD.**, a limited partnership existing under the laws of the State of Florida (the "Surviving Entity") (the Merged Entity and the Surviving Entity are referred to collectively as the "Constituent Entities"), adopt the following Statement of Merger for the purpose of merging the Merged Entity into the Surviving Entity:

1. Entities. The Merged Entity shall be merged with and into the Surviving Entity (the "Merger").
2. Compliance With Laws. As of the time of the filing of the Certificate of Merger, the Constituent Entities have complied with the laws of the states under which they exist and the laws of those states permit the above referenced Merger.

IN WITNESS WHEREOF, each of the undersigned entities have caused this Statement of Merger to be executed as of the 30th day of January, 1998.


