FOURTH AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP

The undersigned having heretofore executed on August 17, 1981 the Certificate of Limited Partnership for RAMBLERS REST RESORT, LTD., a Florida Limited Partnership (referred to below as the Certificate), which Certificate was previously amended by Certificates filed in the Office of the Secretary of State, Tallahassee, Florida, on May 13, 1982, May 12, 1983, and May 12, 1986, do hereby execute, in identical multiple counterparts, having the respective execution pages attached to this Amendment, a Fourth Amendment to said Certificate according to Florida Statute §620.109 as follows:

Paragraph 4 of the Certificate regarding the general partners is amended to read as follows:

4. The General Partners Jan E. Smith and Mark E. McLaughlin are hereby removed as General Partners; henceforth the General Partners are:

L-7855 RRR JES, LLC, a Florida limited liability company, as Managing General Partner at 1111 3rd Avenue West, Suite 110, Bradenton, FL 34205

and

L-7856 RRR MEM, LLC, a Florida limited liability company, as General Partner at 5250 Riverview Blvd., Bradenton, FL 33529

Each of which LLC's has a 1% partnership interest.

Paragraph 9 of the Certificate is deleted and the following substituted in its place.

9. The Limited Partners shall be allocated 98% of partnership profits, which profits shall include but not be limited to, the distributions set forth in Paragraph 13 of this Agreement. The percentage of partnership profits that are allocated to limited partners may hereinafter change from time to time and any future percentage changes may be accomplished without amending the Certificate of Limited Partnership.

In all other respects the Certificate as originally executed and filed continues in full force and effect.
