Pursuant to the provisions of Florida Statutes §620.8907, **LEXMERGE PARTNERSHIP 20301**, a general partnership existing under the laws of the State of Florida (the "Merged Entity"), and **PALM PLACE APARTMENTS, LTD.**, a limited partnership existing under the laws of the State of Florida (the "Surviving Entity") (the Merged Entity and the Surviving Entity are referred to collectively as the "Constituent Entities"), adopt the following Statement of Merger for the purpose of merging the Merged Entity into the Surviving Entity:

1. Entities. The Merged Entity shall be merged with and into the Surviving Entity (the "Merger").

3. Principal Office. The location of the chief executive office of the Surviving Entity is 6954 Americana Parkway, Reynoldsburg, Ohio 43068.

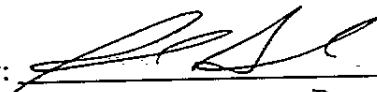

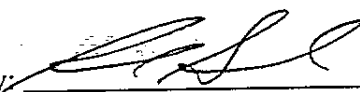
