CERTIFICATE OF AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP OF MOULTRIE APARTMENTS, LTD., A FLORIDA LIMITED PARTNERSHIP

- I. NAME. The name of the Partnership as filed with the Florida Secretary of State May 24, 2007 is Moultrie Apartments, Ltd.
- 2. <u>RATIFICATION AND CONSENT.</u> The Partners consent to the withdrawal of Mid-Plorida Management Corporation, a Florida corporation as General Partner, and substitution of Moultrie Management, LLC, a Florida limited liability company as the new and sole General Partner of the Partnership. <u>LD700005210</u>
 - AMENDMENT. The Certificate is hereby amended as follows:
- a. Mid-Florida Management Corporation, a Florida corporation, is hereby removed as the sole general partner of the Partnership and Moultrie Management, LLC, a Florida limited liability company, shall be the sole general partner of fixed Partnership from and after the date hereof.
- b. The principal address and the mailing address of the new general partner is 7670 South Tropical Trail, Merritt Island, FL 32952
- c. The principal office and mailing address of the Partnership is 76% South Tropical Trail, Merritt Island, FL 32952.
- d. The address of the registered office and name of the registered agent for service of process required to be maintained under Florida law is: John Schmitt, 7670 South Tropical Trail, Merritt Island, FL 32952.
- 5. The foregoing Certificate of Amendment was adopted by the general partner of the Partnership, and has been executed by the withdrawing general partner and the substitute general partner. This Amendment is effective upon complete execution of this Certificate of Amendment, provided it is subsequently filed for record at the office of the Secretary of State of Florida, and upon such execution, this Amendment shall be deemed complete and such Certificate of Amendment shall become a provision of the Partnership Agreement and of the Certificate of Limited Partnership.
