Dear Sir or Madam:

The above-referenced taxpayer requested that we respond to the attached notice dated December 6, 2001. The taxpayer also received a previous notice indicating that the State revoked their authority to transact business as of September 28, 2001. When looking into the matter for the prior notice, the taxpayer realized that they had inadvertently failed to file the 2001 Uniform Business Report, and immediately filed the attached Limited Partnership Reinstatement form on November 29, 2001 along with a check for the \$526.25 filing fee and one for \$500 penalty. The reinstatement form and checks were subsequently returned to the taxpayer because line 7b on the document was filled out showing \$915,000, when it actually should have been entered on line 7a, according to our phone conference with the State. We were directed by the representative from the State to file another reinstatement form with the \$915,000 of contributions entered on Line 7a and checks for the following:

2001 Uniform Business Report	\$526.25
Penalty for 2001	500.00
2002 Uniform Business Report	526.25
Penalty for 2002	500.00

The representative stated that an additional penalty for 2002 was assessed because the taxpayer was not in compliance as of January 1, 2002. We feel that the additional penalty is unwarranted because once the taxpayer was notified of the error they immediately attempted to comply by filing the reinstatement forms in 2001. Had the State analyzed the form it would have seen that the contributions amount was not more than what they had on file but was merely marked in the wrong box and the taxpayer would have been reinstated in 2001, and therefore, no penalty would have been assessed for the 2002 tax year. Based on these facts, we respectfully request that the State abate the 2002 penalty. We have enclosed checks for a total of \$1,552.50 for everything but the penalty for 2002.
