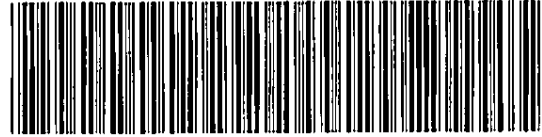

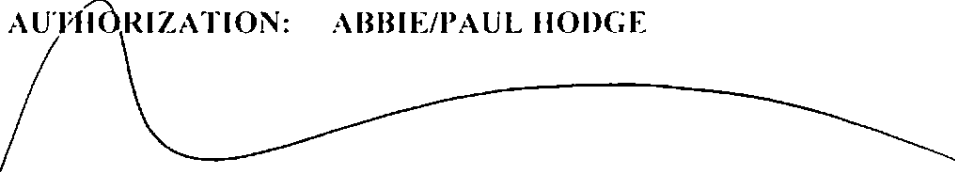

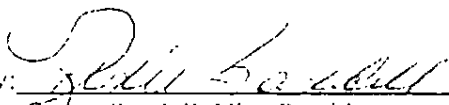
1. The current name of the Partnership is BDG WOODLOCK MANOR, LP.

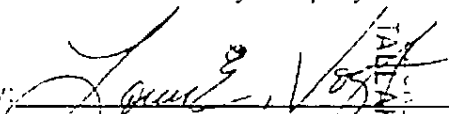
