The Certificate of Limited Partnership was filed with the Secretary of State of Florida on August 14, 1984.

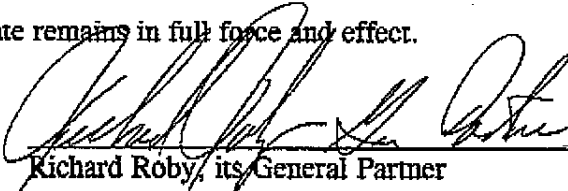
Pursuant to the terms of the Limited Partnership Agreement, the parties unanimously consented to revise the Certificate of Limited Partnership.

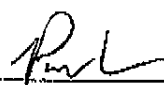
