Pursuant to the provisions of Section 610.109, Florida Statutes this Florida limited partnership, whose certificate was filed with the Florida Department of State on January 7, 1985, and subsequently amended, adopts the following certificate of amendment to its certificate of limited partnership.

WHEREAS, Sydney O. Chase, III withdrew as a general partner of the partnership;

WHEREAS, R. Chase Lasbury, the remaining general partner of the partnership, elected to continue the business of the partnership; and

WHEREAS, Sydney O. Chase, III, as Trustee of the Sydney O. Chase, III Revocable Trust, was elected as a replacement general partner of the partnership.

NOW THEREFORE, Article I, Section 1.3, Paragraph A of the Certificate of Limited Partnership is hereby amended by deleting the entirety thereof and restating same to read, in its entirety, as follows:

"A. General Partners. Sydney O. Chase, III, as Trustee of the Sydney O. Chase, III Revocable Trust, and R. Chase Lasbury shall be the General Partners of the partnership."

This certificate of amendment shall be effective as of the 1st day of January, 1998.


