## SECOND AMENDMENT TO

## AGREEMENT OF LIMITED PARTNERSHIP FOR

THIS SECOND AMENDMENT TO AGREEMENT OF LIMITED PARTNERSHIP FOR SUNSET VILLAS OF CHIEFLAND, LTD.
