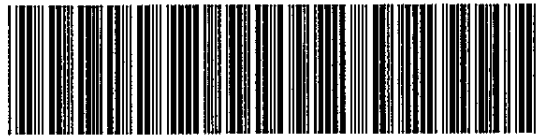

CERTIFICATE OF AMENDMENT AND  
AMENDMENT TO LIMITED PARTNERSHIP AGREEMENT

LEESBURG RRH, LTD. II

This Certificate of Amendment and Amendment to Limited Partnership Agreement is made and entered into this 29 day of April, 2006, by and between the undersigned, and amends that certain Limited Partnership Agreement and Certificate of Limited Partnership for Leesburg RRH, Ltd. II, a Limited Partnership, dated May 3, 1985, and filed with the Secretary of State of the State of Florida on May 9, 1985, Limited Partnership number A19888, and as amended by First Amendment to Limited Partnership Agreement, dated April 1, 1991 and filed with the Secretary of State of the State of Florida on May 31, 1991, and further amended by Certificate of Amendment and Amendment to Limited Partnership Agreement, dated October 14, 1993 and filed with the Secretary of State of Florida on November 24, 1993, and further amended by Certificate of Amendment and Amendment to Limited Partnership Agreement, dated December 30, 1993 and filed with the Secretary of State of Florida on January 14, 1994.

WITNESSETH:

Whereas, Timothy S. Roe has assigned all his interest as limited partner in the limited partnership to Thomas K. Roe and Sheri L. Roe, and Thomas K. Roe and Sheri L. Roe have succeeded to his interest.

Whereas, the undersigned desire to amend the limited partnership agreement and Certificate of Limited Partnership to set forth the substitution of the undersigned as Limited Partners as set forth herein, and the withdrawal of Timothy S. Roe as withdrawing Limited Partner.

Now, therefore, in consideration of the premises, the undersigned do hereby amend the Limited Partnership Agreement and Certificate of Limited Partnership as follows:

1. Substituted Limited Partner. Thomas K. Roe and Sheri L. Roe are hereby substituted for the withdrawing Limited Partner, Timothy S. Roe, and they shall replace Timothy S. Roe as Limited Partner of the Partnership. As substituted Limited Partner, Thomas K. Roe and Sheri L. Roe shall have all of the powers, privileges, obligations and liabilities of Limited General Partners as stated in the Partnership Agreement.


3. Partnership Agreement Remains Unchanged. In all other respects, the Partnership Agreement and Certificate of Limited Partnership remains unchanged.
