

THIS THIRD AMENDMENT to Agreement and Certificate of Limited Partnership (hereinafter "Amendment") is effective the 30th day of March, 2001, by and between Wilton R. Miller and W. Robert Olive as sole general and limited partners in said Agreement and Certificate of Limited Partnership. This amendment is made pursuant to Article XIV of said Agreement and Certificate, and the provisions of the Florida Uniform Limited Partnership Law, Part I, Chapter 620, Florida Statutes;

WHEREAS, W. Robert Olive has assigned, sold and transferred all of his general partnership interest and forty-seven and ninety-nine-hundredths percent (47.99%) limited partnership interest in Exchange Building, Ltd., a limited partnership existing under the laws of the State of Florida, to Wilton R. Miller;

NOW, THEREFORE, said Agreement and Certificate, as amended, is hereby further amended as follows:

1. W. Robert Olive hereby withdraws as a General Partner.
2. The Preamble is amended to delete W. Robert Olive as a General Partner; and to retain Wilton R. Miller as sole and only General Partner.
3. Article V, Paragraph 5.2 -- W. Robert Olive is hereby deleted as a General Partner.
4. Paragraph 4 of the Second Amendment to Exchange Building, Ltd. Agreement and Certificate of Limited Partnership is amended to refer to Article V, Paragraph 5.2.

5. Article VI, Paragraph 6.1 -- W. Robert Olive is hereby deleted as a General Partner

The partnership interests of the partners shall be as follows:

8. Article XV is amended through the deletion of the name and address of W. Robert Olive as a general partner. The following names and addresses are substituted therefor:
