The total amount of the capital contributions of the limited partners is now \$4,594,028.57.

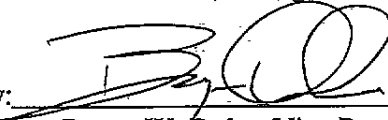

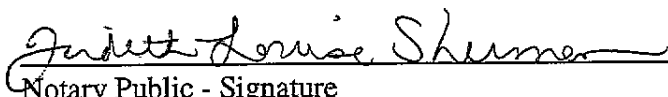
