



Whereas, Hobe Associates, Ltd., a Florida limited partnership ("the Partnership") filed on July 31, 2000, an Amendment to Certificate of Limited Partnership amending the existing Certificate of Limited Partnership, dated the 25th day of November 1986 and which had been amended and restated on May 10, 1999 and filed on May 11, 1999; and

Whereas, the Amendment to the Certificate of Limited Partnership for the Partnership, filed on July 31, 2000, inadvertently listed Science & Industry Int'l, Inc., as the General Partner of the Partnership; and

Whereas, the General Partner of the Partnership prior to the filing of the amendment and subsequent thereto has been Royo International, Inc., and the limited partners desire by this Amendment to amend, correct and restate the amendment to the Certificate of Limited Partnership for the Partnership filed on July 31, 2000.

Now Therefore, the Certificate of Limited Partnership for Hobe Associates, Ltd., is hereby amended and restated as herein below set forth:

1. The following shall be the new Limited Partners of the Partnership in the percentages listed below, replacing all of the prior limited partners who sold their interest in the Partnership with the consent and approval of the General Partner.
