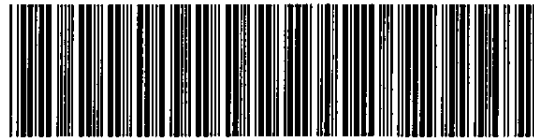

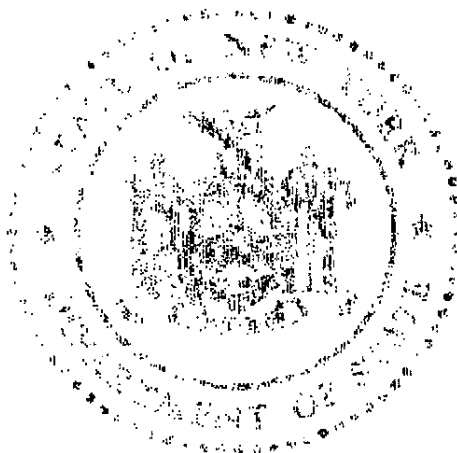

ARTICLES OF ORGANIZATION

OF

H & G POWERLINE, LLC

Under Section 203 of the Limited Liability Company Law.

FIRST: The name of the limited liability company is H & G POWERLINE, LLC.
