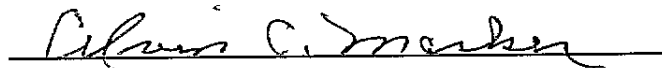
1. The name of the Partnership is Marker Investment Properties, Inc.
