AMENDMENT NO. 2 TO CERTIFICATE AND AGREEMENT
OF LIMITED PARTNERSHIP OF
SCHRIMSHER LAND FUND VII, LTD.

The Certificate and Agreement of Limited Partnership of Schrimsher Land Fund VII, Ltd. (the "Partnership") is hereby amended by the general partner of the Partnership, pursuant to Sections 620.109 and 620.114, Florida Statutes, as follows:

1. Article 4 of the Certificate and Agreement of Limited Partnership, which was originally filed on August 21, 1990 (Document No. A30521) and amended on September 10, 1990, is hereby amended and restated in its entirety as follows to correct the name of the Partnership's general partner. The correct name of the general partner, a Florida limited partnership, is J.S. Schrimsher, Ltd. However, in the September 10, 1990 Amendment to the Partnership's Certificate and Agreement of Limited Partnership, the general partner's name was incorrectly stated to be Schrimsher, Ltd.

4. Name and Business Address of the General Partner. The General Partner of the Partnership is J.S. Schrimsher, Ltd., a Florida limited partnership, whose address is 600 East Colonial Drive, Suite 100, Orlando, Florida 32803.

2. Ratification. The Certificate and Agreement of Limited Partnership will remain unchanged in all other respects and shall remain in full force and effect.
