We have received your document for PANAVISION INTERNATIONAL, L.P. LIMITED and your check(s) totaling \$693.75. However, the enclosed document has not been filed and is being returned for the following correction(s):

Please note that we are returning both an AMENDMENT and a REINSTATEMENT form UNFILED.

We have also RETAINED a total of \$693.75 for these two filings.

We have retained a \$52.50 fee for the AMENDMENT, and a \$641.25 payment for the REINSTATEMENT.

As discussed, there are now TWO PROBLEMS with the Reinstatement document.

First, it appears that the R.A. is being changed to CORPORATION SERVICE COMPANY. If that is so, then CSC will need to SIGN the reinstatement.

Also, the \$641.25 payment covers the \$500.00 penalty fee for 2000, and the \$141.25 UBR fee for 2000.

Because you attempted to file this REINSTATEMENT last year, we will NOT charge a \$500.00 penalty fee for 2001, but we must collect the \$141.25 UBR fee for 2001, which is now due.

Please return the AMENDMENT and the REINSTATEMENT with an ADDITIONAL \$141.25.
