

CERTIFICATE OF AMENDMENT TO CERTIFICATE OF LIMITED PARTNERSHIP

THIS SIXTH AMENDMENT to the partnership agreement of LAZY B CATTLE VENTURE, LTD., a Florida limited partnership, made as of January 1, 2003, by and among LBCV, INC., a Florida corporation, the "General Partner", and H. GARY MORSE, MARK G. MORSE, R. DEWEY BURNSED, MARTIN L. DZURO, GEORGE F. McCABE, JR., RICHARD L. MURRAY, JOHN E. PARKER, STEPHEN J. DRAKE, JOHN F. WISE, PAULD. McDOWELL, DONALD W. MATHEWS, JENNIFER L. PARR, JOHN R. GRANT, MICHAEL E. WEST, RONALD G. HESS, C. DALE BORROWMAN, JAMES CICHIELO, STEVEN M. ROY, and TRACY MATHEWS, the "Limited Partners".

WITNESSETH:

WHEREAS, on December 24, 1991, LAZY B CATTLE VENTURE, LTD., a Florida limited partnership, was formed by filing an Affidavit and Certificate of Limited Partnership with the Secretary of State of the State of Florida; and the partners at that time entered into a Limited Partnership Agreement (the "Agreement") whereby they agreed to carry on certain activities for their mutual benefit, according to the terms and conditions set forth in said agreement; and

WHEREAS, the Agreement was duly amended by an instrument dated October 24, 1997 to extend the permissible term of the Partnership; and

WHEREAS, the Agreement was duly amended by a Second Amendment to Limited Partnership Agreement dated May 1, 1996, adding additional limited partners; and

WHEREAS, the Agreement was duly amended by a Third Amendment to Limited Partnership Agreement dated January 1, 1997, adding an additional limited partner; and

WHEREAS, the Agreement was duly amended by a Fifth Amendment to Limited Partnership Agreement, dated July 31, 2002, adding an additional limited partner; and

WHEREAS, on January 1, 2003, H. Gary Morse assigned a 5% limited partnership interest to his wife, Reneè B. Morse, and, subsequently, Reneè B. Morse assigned a 5% limited partnership interest to Tracy Mathews, all with the unanimous consent of all Partners; and

WHEREAS, the Partners now wish to further amend the Agreement to reflect the foregoing changes in the General Partners and Limited Partners and their respective interests in the Partnership.
